CORYS GATHER IN SALEM

55 Cory cousins gathered in Salem, Mass August 7th, 8th and 9th for the Cory Family Reunion. Our headquarters for the reunion was the Hawthorne Hotel in the heart of Salem.

Most Cory cousins began arriving Friday afternoon and evening. Many cousins spent the day enjoying the sights and sounds of Salem as they remember the 300th anniversary of the Salem witch trials. Friday evening the society showed the award winning film "Three sovereigns for Sarah", starring Vanessa Redgrave as Sarah Cloyce, the sister to both Rebecca Nurse and Mary Easty, who perished during the Salem Witch period 300 years ago.

Saturday morning we gathered at 9:00 AM to meet our walking guide, Jim McAllister. Jim took us on a walk around historical Salem. We saw the grave Mary Cory, the second wife of Giles, and the probable field where Giles was pressed to death 300 years ago. Next we split into two groups to visit the Witch Museum and the Essex Institute. At the Essex Institute we were taken through the whole witch trial process. We were asked to participate which created a greater understanding of the entire episode in 1692 Salem. At 12:30 PM we gathered at the Witch Trial Memorial to present t.o the Tercentenary Committee a check from the National Cory Family Society in memory of Giles and Martha Cory in the amount of \$500.00 The memorial is a fitting tribute to all who died during the witch hysteria. After lunch

boarded a bus for Pioneer Village and the House of Seven Gables. Our guide was none other than Giles Cory. In reality Giles was played by Erik Rodenheiser, a local actor. As we left the bus he gave everyone a stone to remember him. Giles (Erik), it will be along time before we forget You!! The day was completed with a bay view dinner at Victoria Station.

Sunday morning in the rain a few hearty souls worshiped together at the First Church of Salem. This is the oldest continuous congregation in the United States. At 1:00 PM our annual business meeting and banquet were held in the beautiful banquet room of the Hawthorne Hotel. The Mayor of Salem, Neil Harrington, welcomed the National Cory Family Society to Salem for our reunion. After the banquet and business meeting we heard from our guest speaker, Col. Eleanor Spiller, who spoke on Giles Cory and the Salem witch trials. Immediately after our traditional group picture we said farewells until next year when we meet in Rhode Island.

GILES CORY

To end our story of witch craft an Giles CORY of Salem Massachusetts. A lot has been written on him and a lot of misconceptions in regard to to his death and descendants. Hopefully I can try to put all this to rest.

The Cory Family Society held their annual reunion in Salem this past August, and as such we were privileged to hear the sad tale of Giles and the witch craft trials many times plus a movie. It seems as though some teenage girls, along with one adult lady and a servant from the Bahamas, were meeting and practicing a sort of VooDoo. They were caught, chastised and some punished. They, under the lead of the elder girl, started to tell lies about different town folks which included Witch Craft accusations. There were twenty nine men and women put to death on the gallows in Salem as a result of the trials. Martha Cory, Giles third wife was arrested 19 March, jailed in Boston in April, tried 9th September, and executed by hanging on 22 September 1692 Giles was arrested 18 April, failed, and on the 17 September taken to a field near the jail, striped of his clothing. laid on the ground, boards were placed upon him and heavy rocks then placed on the board. After two days he was asked if he would plead guilty and his only answer was more weight. He died soon after. The date was 19 September 1692 Giles conveyed all his property to his daughters through their husbands while in iail. He made his will on 25 July 1692, thereby preventing the crown or provincial government from confiscating his property.

Giles Cory was born ca 1619 in England. There is, I am told but not have had the privilege of obtaining, a copy of his baptismal record from England. When He arrived in the Americas is not certain but there is evidence he was in Salem in 1640. There are quite a few entries in the court documents as to his behavior, It was not all good but in those times any accusation was an offense against the state. Giles married first, Margaret, the mother of all his children. We believe they were married in England. Giles had no male heirs. There daughters were Martha, married William Cleaves in 1675. They had three children. Martha died in 1683. Margaret. also married William Cleaves on 18 May 1683. They had five children, After William died, Margaret married Jonathan Biles, Deliverance born 5 August 1678, married Henry Cross 5 June 1683. Elizabeth, married John Moulton. Mary, born 1653 married John Parker, she died before Feb 1697. They had seven children. Giles second wife was Mary Brite, they were married 11 April 1673. She died 27 August 1684 She is buried in Salem Grave vard. Giles third wife was Martha Penoyer, (widow of Henry Rich) Married in 1685. Martha had a son Thomas. He shows up as a petitioner for loss and damages resulting from his mother being hanged illegally during the witch trials. He was awarded £50 on June 29 1723. The below document is the Deposition of one of the girls who accused Giles of witch craft I had the privilege of seeing the archive where all the documents are kept. Mr La Moy was kind enough to make us a copy.

The above document is from the records of the Court of Oyer and Terminator, 9 September 1692, property of the Supreme Judicial Court, Division of Archives and Records Preservation, on deposit at the Essex Institute, Salem, Mass.

(Mercy Lewis v. Giles Cory)

The Deposition of Mercy lewes agged about 19 years who tetifieth and saith that on the 14th April 1692 I saw the Apperishtion of Giles Cory com and affect me urging me to writ in his book and so he continued most dreadfully to hurt me by times beating me & almost braking my back tell the day of his examination being the 19th April and then allso dureing the time of his examination he did afflect and tortor me most greviously: and also several times sence urging me vehemently to writ in his book and I veryly beleve in my heart that Giles Cory is a dreadfull wizzard for sence he had ben in prison he or his apperance has com and most greviously tormented me.

Mercy Lewis affirmed to the jury of Inquest that the above written evidence is the truth upon the oath; she has formerly taken in the court of Oyer & terminer: Sept'r 9: 1692

PROFILES

HARVEY VASNEMAN LINCOLN CORY

David A. Cory MD Harvey Vaneman Lincoln Cory was born June 7, 1860. He was named after a neighbor in the vicinity of Syracuse Indiana. Since it was a presidential election year, we may infer that he was also a namesake of Abraham Lincoln. Lincoln's American Progenitors were John I, John II, John III, Elnathan, Ebenezer, Elnathan, Jeremiah William and Robert V Cory. Lincoln's grandfather Jeremiah William Corv. grandmother Dorothy (Dolly) Martin, and their children moved to Elkhart County, Indiana from Pace County, Ohio in 1831. Among their children were Robert V and Abijah Curtis. Robert V married Elizabeth Gordy October 10, 1844, settling Jackson Township, Elkhart County Indiana. They were the parents of eight children, Orange Lemon, Dorothy Jane, Jerome, Jeniza, Kames, Lincoln, alice and Partner. Robert V Cory was, by all accounts, an eccentric of rough exterior and in no sense religious, who made his living as a farmer, auctioneer and veterinarian. On his farm were two adjacent barns, connected by a sign which read.

R. V. CORY, VETERINARIAN SURGEON OR LUCKY BOB OF GINGER HILL

Never Worked and Never Will

Lincoln's religious standards were different than his father's, and the young man joined the church of the Brethren at age 18. At about this time, on April 23, 1879, tragedy struck when Lucky Bob died at home from a selfadministered overdose of Fowler's solution of arsenic and morphine. Just south of Bob's farm, brother Curtis Abi jah Corv. known as Curt, had set up housekeeping in Kosciusko County. His first wife, Sally Ann Mann, died in 1845 after bearing three children. In 1846, Curt married Matilda Wood Gunter, who bore

nine children. The youngest of the nine was Pauline Celestine (Sella), born September 26, 1862. By the time she reached age nineteen she had fallen in love with her neighbor and first cousin, Lincoln. Despite parental protest, Lincoln and Sella eloped and were married by a justice of peace at Sturgis. St Joseph County Michigan, on January 20, 1882. they returned to Indiana to live and were the parents of six children, Van, Maud, Dean, Tead, Fay, and Lee . In addition to farming, Lincoln carried on in the tradition of his father as a successful and popular auctioneer in the area around Syracuse.

Tragedy struck once again on August 4, 1893. On Saturday evening, Sella and Lincoln went into Syracuse for an ice cream festival they returned to their farm and went to sleep in the barn where the family were temporarily staying while the new house was being built. Around midnight Lincoln was awakened by the struggle of Sella who soon expired, apparently of heart disease, at age of thirty.

Lincoln married second, Viola Shelmadine, who assumed the role of mother to his six children. In February, she bore the first of six more children, a girl named Eve. On March 7, 1896, Lincoln's mother Elizabeth, passed away at the age of seventy one. In July 1896, while the family lived in a sod house in Kansas, a son Guy was born. The home steading attempt was a failure, and by the time Ruth was born in May 1898. the family was back in Indiana, where the remaining children. Marie, Joy and Noble were born. Lincoln was said to have been a man of unusual temperament who looked on the bright and joyous side of life, despite the setbacks he had suffered. The final tragic chapter of his life began in Goshen, Indiana on June 20, 1912, when the horse he was driving was frightened by an automobile

and ran away, throwing Lincoln from his buggy. He suffered a broken right leg and suffered internal injuries. He was alleged to have had a heart condition which, combined with his injuries, ultimately lead to his death July 12. 1912. His funeral was said to have been the largest held in Syracuse for many years, with over a thousand people coming to pay their last respects. Only about 200 of these could be seated in the United Brethren Church where the services were held.

following auote attributed to Lincoln Cory by the Syracuse Journal, which reported his death on the front page of the July 18, 1912 edition: "I have no wealth or worldly possessions to leave my children, but I consider that one of the best legacies, that a man can leave the world, is a well educated Family." The Milford Mail of July 18, 1912 reported the death of "Lincoln Cory, the prominent farmer and famous auctioneer," and ask who would take up the work of Lincoln as he had taken up the work of his father Bob. The taken up Vacancy was Lincoln's son Lee, who not only learned the auctioneer's trade, but fulfilled his father's wish for educated children by attending Manchester College and becoming a minister in the Church of the Brethren.

George Soule, came over on the Mayflower was married to Mary Buckett (Becket), lived in the Plymouth Settlement. They children, a daughter Elizabeth, who married Francis Walker. They had children, a Son Isaac who married Desire Shelly. They had children, a daughter Naomi, who married Abner Cory, the son of John IV of Westfield New Jersev.

A man inherits his father's name, but by his deeds he makes his own reputation. Sons, and daughters too, add luster...or tarnish... to their family's name. So, when all is said and done, what's in a name? A rose by any other name would smell as sweet. (And a skunk by any other name would smell no better.) One finds the fruit of a tree on the branches... not in roots.

That is where it stops, it must be won, issued or bestowed again before it can be legally used. Over the years we Americans have taken pride in the coats of Arms our fore fathers have owned. Maybe not legal but what the heck.
